2024 Annual Meeting - Save the Date! Tuesday, November 12th is our annual meeting at the Hermitage Police Precinct. Sign in to start at 6:30pm with meeting beginning at 7pm. Meeting notice, agenda, proposed 2025 budget and ballots will be mailed in mid-October. At this time we expect the Annual Assessment to remain at \$400. Installment plans are not available and the entire assessment is due by January 31st, 2025 so plan accordingly.

Cleaning and Roof Maintenance Policy - During the November 2023 Annual

Meeting, the roof maintenance policy was upheld and inspections will begin Spring 2025. The entire Board will inspect and review prior to issuing a violation notice to a homeowner. The Cleaning & Roof Maintenance Policy will be added to our website soon. Here it is:

Cleaning and Roof Maintenance Policy

Black streaks along roof lines are caused by blue-green algae growth. While the algae itself is not hazardous, the accompanying mold that grows beneath the algae can be.

A minimum of 66% of any portion of the roof must display the black streaking in order to issue a violation notice. The entire roof does not necessarily require the soft wash cleaning.

This notice will identify the specific roof portion in need of cleaning and include a photo – this is generally the north side that is sun deprived.

Many homes have recently had roofs replaced with Algae Resistant shingles which were not available when most of the Meadows of Seven Points was built. This will reduce black streaking going forward!

Compliance Report: Violations in July - 1 trash can, 1 trash can screen, 1 mailbox violation, 1 basketball goal, 1 landscaping violation encroaching in neighbor's yard and drainage culvert, 5 lamp lights not working.

Grounds - The Board will be addressing the common ground areas surrounding the electrical boxes. We will be looking into planting grass seed and landscaping. Also, we will be researching options to protect our new planted trees from damage caused by the deers.

Reminder: This is the time to refurbish your mailboxes, lamp posts if needed. The Board will be assessing the stop sign posts for refurbishing.

Per the Amended & Restated Covenants, Conditions and Restrictions, ALL exterior modification/changes to your property must have a submitted and approved ACR application on file prior to the start of construction.

This includes but not limited to: changing paint colors on trim, windows, doors, deck additions/replacements, driveway additions, pools, spas, permanent basketball poles, recreational play structures, roof replacement, trash can screen, fences - new or replacement, sunrooms, room additions, window replacements.
