### **ARC REMINDER**

Per the Amended & Restated Covenants, Conditions and Restrictions, **ALL** exterior modification/changes to your property must have a submitted and approved ACR application on file prior to the start of construction.

This includes but not limited to: changing paint colors on trim, windows, doors, deck additions/replacements, driveway additions, pools, spas, permanent basketball poles, recreational play structures, roof replacement, trash can screen, fences - new or replacement, sunrooms, room additions, window replacements. ### **January 8th HOA Board Meeting Notes**

**Financial Report** (Jude Barwig): Half way through the month and one-half of our homeowners have paid their 2024 Annual Assessments! Very much appreciated!

Balances as of 1/16/2024: Checking: \$17,686.34 Money Market: \$24,887.14 Capital Reserve: \$57,582.17

As discussed at the Annual Meeting, \$20,000 was transferred mid-month from the Money Market account to our Capital Reserve account. The ultimate goal is to have monies in the Capital Reserve account equal to one year's budgeted annual dues assessment - approximately \$77,000.

Transfer fees, when a home changes ownership in MOSP, are always designated for the CR account. All dues payments are deposited into checking initially. A transfer will be made to the Money Market account to capture the better interest rate.

**Compliance Report** (Jude): No outstanding compliance issues as no inspections occurred in December. Inspections resumed January 8 & 10 with reports of missing shutters, trash screens affected by our high winds and 11 lamp post light violations.

**Grounds** (Jerry Shoulders): Summit Landscaping completed the clean up of several of our open areas. Removal of the limbs along the Willow Pond bridge to be completed within the next week when the weather breaks. An erosion issue has been reported behind Pauls Trail and our engineer will inspect and provide a plan.

RootNashville.org is scheduled to deliver our free trees in February. The Board is researching cost effective ways to keep deer from destroying these young trees. Suggestions???

Board members are also working with Summit on a plan for replacing our dead foliage at the front entrance.

**Calming Pads** - tabled until February as we have not yet heard from Metro regarding our Street Calming application.

**Solar Lights along Willow Pond -** The Board has ordered and installed 4 decorative bases. Our supplier is having stock issues and they sell out as soon as they receive them. We check every single day.

**Welcome Committee** (Carrie Hill): No new neighbors in January but we do have 2 homes under contract with February closing dates.
